### INTERNAL REGULATIONS GENERAL CONDITIONS

#### 1. Admission Conditions:

To be admitted to enter, set up, and stay on the campsite, prior authorization must be obtained from the manager, who is responsible for ensuring proper order and discipline on the campsite and for enforcing these regulations.

Staying on the campsite implies acceptance of and commitment to adhere to these regulations.

### 2. Police Formalities:

Any person planning to stay for at least one night on the campsite must present their identification and complete the formalities required by the police.

Unaccompanied minors will only be admitted with written permission from their parents.

#### 3. **Installation**:

Tents, caravans, and related equipment must be set up at the designated spot according to the manager's instructions.

### 4. Reception Office:

Open from 9:00 AM to 12:00 PM and 3:00 PM to 6:00 PM in low season, and from 8:30 AM to 12:30 PM and 3:00 PM to 7:00 PM in high season.

At the reception, you can get information about the campsite services, local shops, sports facilities, tourist attractions, and other useful contacts.

#### 5. **Fees**:

Fees are paid at the reception, and their amounts are displayed at the campsite entrance and reception. They are due according to the number of nights spent at the campsite.

Guests must inform the reception of their departure the day before. Campers leaving before the reception opens must pay the fees the day before.

## 6. Noise and Silence:

Campers are urged to avoid any noise or conversations that could disturb their neighbors. Sound devices must be adjusted accordingly. Doors and trunks must be closed as quietly as possible. Silence must be observed between 11:00 PM and 7:30 AM.

Dogs and other animals must never be left loose or alone at the campsite and must be under the civil responsibility of their owners. A valid vaccination record will be required at checkin.

# 7. Visitors:

After authorization from the manager, visitors may enter the campsite under the responsibility of the camper who hosts them. Visitors must pay a fee (displayed at the entrance), and vehicles of visitors are not allowed inside.

Visitors do not have access to the pool or showers.

### 8. Vehicle Circulation and Parking:

Inside the campsite, vehicles must not exceed a speed limit of 10 km/h.

Circulation is prohibited from 11:00 PM to 7:30 AM. Only vehicles belonging to campers can circulate on the grounds. Parking on camping spots is strictly prohibited and must not obstruct circulation or the installation of new arrivals.

## 9. Maintenance and Respect for Facilities:

Disposing of wastewater on the ground or in the gutters is forbidden.

Caravanners must dispose of their wastewater in designated areas.

All garbage, waste, and paper should be placed in the recycling bins.

Campers must refrain from any actions that could harm the cleanliness, hygiene, or appearance of the campsite, particularly its sanitary facilities.

Washing outside designated washing areas is prohibited.

Hanging laundry is allowed near the shelters until 10:00 AM, as long as it does not disturb neighbors or look unsightly.

### 10.Safety:

#### a) Fire

Open fires (wood, charcoal, etc.) are strictly forbidden, including in residential areas. Stoves must be in good working order and used safely.

In case of fire, immediately notify management. Extinguishers are available for use in emergencies.

A first aid kit is available at the reception.

## b) Theft

Management is responsible for objects left at the reception. Campers are responsible for their own installations and belongings and must report any suspicious persons to the management.

While the campsite is monitored, campers are advised to take necessary precautions to safeguard their equipment.

#### c) Games

Violent or disturbing games cannot be organized near facilities.

Children must always be supervised by their parents.

#### 11.Dead Storage:

Camping equipment not in use may only be left on the site with the manager's consent and in the designated areas. A fee will apply for "dead storage."

## **12.Notice**:

The internal regulations are posted at the campsite entrance and at the reception.

It is available upon request.

# 13. Violations of Internal Regulations:

If a resident disturbs others or fails to comply with the regulations, the manager may warn them to stop the disturbances, either orally or in writing.

In case of serious or repeated violations, after being warned, the manager may terminate the contract.

For criminal violations, the manager may call the police.

#### **14.Special Conditions:**

From 11:00 PM to 7:30 AM, vehicles are not allowed to circulate on the campsite, and campers must leave their vehicles in the parking lot.

To ensure everyone's peace, lawnmowers and other noisy equipment should not be used between 12:00 PM and 2:30 PM.

Any damage to the rental units will result in partial or full loss of the deposit.
